### 3. Описание на опасностите

**Main hazards:** Flammable. Harmful to aquatic organisms, may cause long-term adverse effects in the aquatic environment. Harmful: may cause lung damage if swallowed. Repeated exposure may cause skin dryness or cracking.

**Other hazards:** In use, may form flammable / explosive vapour-air mixture.

- Inhalation:** Remove casualty from exposure ensuring one's own safety whilst doing so. Consult a doctor.

### 5. Мерки при гасене на пожар

- Clean-up procedures:** Absorb into dry earth or sand. Transfer to a closable, labeled salvage container for disposal by an appropriate method. Do not use equipment in clean-up procedure which may produce sparks.
